It was noted this meeting did not have a full quorum so could not make decisions but the time was used to progress ongoing actions through discussion.

1. Briefing for Joint Committee: City Deal Portfolio

Dates for the Joint Committee and briefing sessions have been moved due to a by- election and 2024/5 budgeting processes. The Joint Committee is now planned for 1^{st} February. ID will be invited to a prebriefing session w/c 15/1/24 or 22/1/24.

Attendees reviewed and discussed the current status of each project, the reasons for lack of progress to date and the challenges facing those projects which had now been approved. The constraints of the City Deal arrangements were also considered especially the inability to move funding easily from one project to another.

It was agreed that REAG will develop a presentation for the Joint Committee in January with 3 key messages

- a. The spend profile of the Deal should not be pushed further to the right with large amounts being forecast for years 9 and 10. This puts delivery and funding at risk, particularly as SG and UKG are looking for ways of recouping uncommitted public spending.
- b. There is a need for realism around projects that are clearly unfeasible or non-viable and the Joint Committee should make a clear decision not to proceed with these.
- c. Uncommitted funding should be committed as quickly as possible on viable projects. Blockers to achieving this such as lack of capacity to develop business cases should be supported by all partners as a matter of priority.

2. Briefing for Joint Committee: City Deal Private Sector Engagement

The group discussed the lack of a current Regional Economic Plan and the inability to align the Deal outcomes to strategic intents.
